Piers has been in contact with the BDI, who provide insurance to beekeepers, and has asked that the following information about the BDI be included in this newsletter.

# Information about the BDI (Bee Diseases Insurance)

#### **Purpose**

The purpose of BDI is to help in the control of honey bee diseases by providing compensation to people who have their equipment destroyed by Defra. Destruction of equipment is a legal requirement in cases of colony infection by a notifiable disease under The Bees Act 1980 and Bee Diseases Control Order, 2006, such as Foul Brood, and

it is aimed at preventing disease spread. An additional purpose of BDI is to sponsor research into the causes of bee health problems and help to educate beekeepers about the issues in bee health and management of bee diseases.

#### History

BDI was set up over seventy years ago and is owned by its member beekeeping associations of England and Wales. There are no premises or staff; it is run by beekeepers who work from their homes.

Your association is a member of BDI and it owns one share with a nominal value of £1 but no value other than an entitlement to vote at the BDI AGM.

BDI is registered under the Industrial and Provident Societies Acts, regulated by the Prudential Regulation Authority supervised by the Financial Conduct Authority. One of the requirements is that BDI has adequate reserves to meet claims even in a worse-case scenario. In addition it has to make sure that membership subscriptions, that is the colonies included in the basic subscription together with premiums for additional colonies, are sufficient to cover the claims and expenses for a normal year.

#### Rules

The rules of BDI require each member association to pay a subscription based on the number of association members, and to arrange insurance for all its beekeepers. This minimum (basic) subscription includes cover for up to three colonies. The basic subscription rate together with the rates for additional colonies is advised to treasurers in August, for the coming insurance year. BDI Insurance covers the calendar year from 1 January to 31 December, regardless of your association's financial year.

Spring and Autumn Returns

The BDI Treasurer will ask associations to make a spring return by 30 April and an autumn return by 1 September each year. You will be sent an e-mail/letter explaining the procedures.

It is the responsibility of the person who collects membership subscriptions to advise the association member of the need to be fully covered. If a member has underpaid for the number of colonies he/she is responsible for, any claim will be invalidated. More seriously, when members underpay they deny all members the opportunity for developing the education and research role, which is one of our most important objectives.

It is clear that asking members to confirm the full number of colonies for which they are responsible is sometimes a difficult task. If a member wilfully refuses to make the correct payment, you may need to consider whether they are in breach of your association's membership rules. In this instance it may be helpful to reflect that it is the association that is the owner of BDI Ltd and underpayment means that the compensation scheme is weakened and with it the work that BDI was established to undertake. If all members pay their dues correctly, and subscription income rises, we hope that it will be possible to limit subscription increases in the future, whilst at the same time sponsoring research and education in order to minimise or even eradicate the honey bee diseases.

#### **BDI Certificates**

The BDI certificate is intended to be used as a receipt not only for BDI subscriptions, but also for association membership subscriptions, capitation fees, donations and any other charges your association makes. It also gives details of the cover provided by BDI and it is a

vital document should any member's colonies suffer from one of the foul brood diseases and they need to claim compensation.

Member associations can choose whether to use paper BDI certificates or eReturn, which includes the facility to e-mail receipts or print them for posting.
